Requirements for the Two-year Eden Energy Medicine Certification Program in Phoenix, Arizona (EEMCP)

Before you register for EEMCP, we ask that you decide whether to enroll in the Wellness Program track or the Eden Energy Medicine Certification Program track. (You can always change your mind later.)

The Wellness Track is designed for students interested in applying Energy Medicine to themselves, friends, and family.

The EEM Certification Track is recommended for students who plan on applying the energy methods professionally or who want to heighten their proficiency.

Eden Energy Medicine Certification Program Requirements:

1. \$300 one time fee is paid to Innersource to process your application and your participation in REP. This needs to be paid before you take your test and do the demo for Class 1.
2. \$50 per class to have written testing with Lisa Buford for Certification track and Wellness track. \$100 per class for demonstration with Lisa for Certification Track only.
3. Six-hour live class with Donna Eden*
4. Five-day Energy Medicine Class (with Donna Eden or on DVD home study with written test)*
5. Six-hour review class the day before the first class of year two.
